FreshDesk Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "General Corporation Law"),

**DOES HEREBY CERTIFY:**

**FIRST:** That the name of this corporation is FreshDesk Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on August 18, 2010 under the name FreshDesk Inc.

**SECOND:** That the Board of Directors of this corporation duly adopted resolutions setting forth a proposed amendment to the Amended and Restated Certificate of Incorporation of this corporation (the "Restated Certificate"), declaring said amendment to be advisable and in the best interests of this corporation and its stockholders, which resolution setting forth the proposed amendment is substantially as follows:

**RESOLVED,** that Article I of the Restated Certificate be deleted and replaced in full with the following:

**"ARTICLE I**

The name of this corporation is Freshworks Inc."

**THIRD:** That said amendment has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law.
