

Dear Keith:

We are pleased that you have agreed to become a consultant to 4-Combinator Incorporated (the "Company"). Company is an "incubator" entity that provides support services to certain other entities, including Butterfly Network, Inc. ("Butterfly")

7. Ownership of Ideas, Copyrights and Patents.

(a) Property of the Company. All ideas, discoveries, creations, manuscripts and properties, innovations, improvements, know-how, show-how, inventions (whether patentable or not), designs, trade secrets, developments, apparatus, techniques, methods, software, source and object code, technology, biological processes, cell lines, laboratory notebooks and formulas in or related to the Field of Interest of a Supported Company, whether or not reduced to practice and whether or not patentable or copyrightable, which were or may be conceived, reduced to practice or developed during the Term or any other time during which you are providing services to the Company or with the assistance of financial or other support from the Company or a Supported Company (or if involving Confidential Information, conceived or developed during or after the Term) by you, whether alone or in conjunction with another or others, whether or not during business hours, and whether at the request or upon the suggestion of the Company, a Supported Company, or otherwise, (all of the foregoing, as well as any related improvements, modifications or derivatives thereof, being hereinafter referred to as the "Inventions"), shall be the sole and exclusive property of the Company or the applicable Supported Company. To the maximum extent permitted by law, the Inventions referred to in the prior sentence will be deemed "works made for hire" as the term is used in the United States Copyright Act. You hereby assign to the Company (or the applicable Supported Company, as the Company may specify) all of your worldwide right, title and interest in and to all of the Inventions, and all intellectual property rights therein, including the right to sue for and recover for past infringement. All Inventions shall constitute the Confidential Information of the Company (and/or the Supported Company, as the Company may specify), subject to the protections set forth in Section 6 of this Agreement. You represent and warrant you will conduct all services for or relating to the Company or a Supported Company using your personal and/or equipment and resources owned by the Company or the Supported Company (and no equipment or resource of any kind owned by any

other person or business). You agree to maintain and furnish to the Company complete and current records of all such Inventions and to disclose to the Company in writing any such Inventions. Upon termination of your consulting arrangement with the Company, you shall provide to the Company in writing a full, signed statement of all Inventions in which you participated prior to termination of the consulting arrangement. You further represent and agree that (i) none of the Inventions will violate or infringe upon any right, patent, copyright, trademark or right of privacy, or constitute libel or slander against or violate any other rights of any person, firm, corporation or entity, (ii) that you will use your best efforts to prevent any such violation, and (iii) that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment. You further waive any "moral" rights, or other rights with respect to attribution of authorship or integrity of any of the Inventions that you may have under any applicable law, whether under copyright, trademark, patent, unfair competition, defamation, rights of privacy, contract, tort or any other legal theory.
