PATENT TRANSFER AGREEMENT

THIS AGREEMENT is made this day of January 31th, 2019

BETWEEN

Ortic 3D AB, org. nr 556668-5292, a company incorporated under the laws of Sweden with its office located in Borlänge, Rågåkersgatan 5 (referred as ORTIC 3D).

AND

Ingvest AB, org. nr 556590-2656, a company incorporated under the laws of Sweden with its office located in Borlänge, Nol Saras väg 8 (referred as INGVEST).

WHEREAS ORTIC 3D and INGVEST entered into an agreement in 2006, whereby ORTIC 3D from INGVEST acquired patents with an obligation to retransfer them to INGVEST, should ORTIC 3D at any point choose not to uphold the patents or parts thereof.

WHEREAS ORTIC 3D has chosen not to uphold certain patents.

NOW THEREFORE, the parties hereto agree as follows:

Transfer of patents

On this day ORTIC 3D now transfers back to INGVEST the following patents:

Amendments

Only those amendments and additions to this agreement that are made in writing and signed by the parties are valid.

Disputes/ Arbitration

Any dispute, controversy or claim arising out of or in connection with this agreement, or the breach, termination or invalidity thereof, shall be finally settled by arbitration in accordance with the Rules of the Arbitration Institute of the Stockholm Chamber of Commerce.

The language to be used in the arbitral proceedings shall be English.

This agreement has been executed in two copies of which the parties have taken one each.




