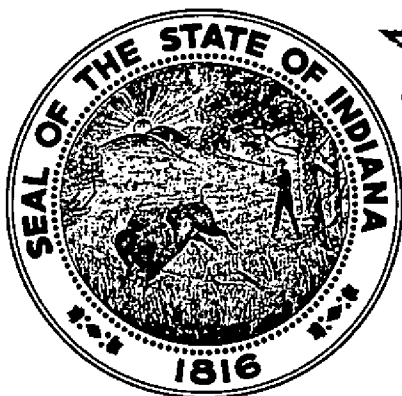

; and except as amended by the foregoing, the Articles of Organization remain in full force and effect.


