ASSIGNMENT

This Patent Assignment ("Assignment"), dated as of January 29, 2012, and effective as of November 1, 2012, is between Abbott GmbH & Co KG, a limited liability company organized and existing under the laws of Germany, having a place of business at Max-Planck Max-Planck-Ring 2, 65205 Wiesbaden ("Abbott KG"), and AbbVie Deutschland GmbH & Co KG, a limited liability company organized and existing under the laws of Germany, having a place of business at Max-Planck-Ring 2a, 65205 Wiesbaden ("AbbVie KG").

WHEREAS, Abbott KG has agreed to assign and transfer to AbbVie KG and AbbVie KG has agreed to acquire and accept from Abbott KG the patent applications and patents set forth on the Abbott GmbH & Co KG Patent Schedule A (the "Abbott KG Patents") attached hereto,

NOW, THEREFORE, in consideration of the premises, mutual covenants and provisions herein contained, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the parties hereto agree to execute this Assignment, as follows:

1.0 Assignment. Abbott KG has assigned and/or by these presents does hereby assign, transfer and convey unto AbbVie KG, Abbott KG's whole and entire right, title and interest (i) in and to the inventions claimed in the Abbott KG Patents, including all patents granting from said applications on said Abbott KG Patents or any continuation, continuation-in-part, division, renewal, substitute, reexamination or reissue thereof, including any patents obtained based upon a claim of priority to any patent or patent application on said Abbott KG Patents and (ii) in and to all rights to sue for and collect damages resulting from past, present and future infringement of said patents and patent applications in (i).

2.0 Enjoyment. The patents and patent applications subject to Paragraph 1 shall be held and enjoyed by AbbVie KG, for AbbVie KG's use and benefit, and for AbbVie KG's legal representatives and assigns, to the full end of the term or terms for which same may be granted, as fully and entirely as the same would have been held by Abbott KG had this assignment and transfer not been made.

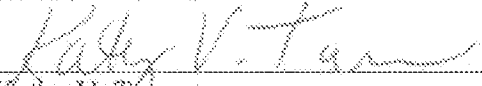

Without limiting the foregoing, each of Abbott KG and AbbVie KG shall cooperate with the other without any further consideration to execute and deliver, or use commercially reasonable efforts to cause to be executed and delivered, all documents as may reasonably be necessary to secure the vesting in AbbVie KG of all rights assigned to AbbVie KG by this Assignment, including without limitation any documents required to record this Assignment with local patent offices.

4.0 Counterparts. This Assignment may be executed in one or more counterparts, all of which shall be considered one and the same document.

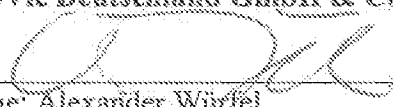

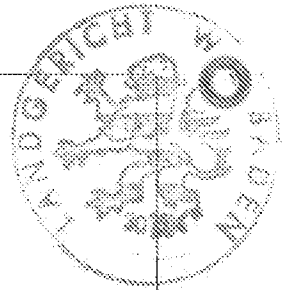
