Recitals:

- (A) The Assignee has applied to the Patent Office of the United Kingdom for a Patent under the Patents Act 1977 under the Application Number listed in the Schedule ("the Application"), further particulars of which are given in the Schedule in respect of the Invention disclosed in the Application ("the Invention").
- (B) The First Inventor and the Second Inventor claim to be the true and joint inventors of the Invention.
- (C) By virtue of the employment of the First Inventor by the First Assignor, and of a confirmatory Agreement/Assignment of ... 6th December 2017 ... the First Inventor's right title and interest in the Invention belong, as between him and the First Assignor to the First Assignor absolutely.
- (D) By virtue of the employment of the Second Inventor by the Second Assignor, and of a confirmatory Agreement/Assignment of ... 12th January 2018 ... the Second Inventor's right title and interest in the Invention belong, as between him and the Second Assignor to the Second Assignor absolutely.
- (E) The First Assignor and the Second Assignor have agreed to assign to the Assignee all their rights, title and interest in the Invention and the Application upon the terms and conditions set out below.

Operative provisions:

- 1 In pursuance of the said agreement and in consideration of the sum of £1 now paid by the Assignee to each of the First Assignor and the Second Assignor (receipt of which the First Assignor and Second Assignor hereby acknowledge) the First Assignor and the Second Assignor with full title guarantee HEREBY ASSIGN unto the Assignee:
 - 1.1 the Invention and the full and exclusive benefit of it;
 - 1.2 all the rights of the First Assignor and the Second Assignor in and to the Application and the full and exclusive benefit of them and all rights privileges and advantages associated with them;
 - 1.3 the full right to apply for and obtain patents or other similar forms of protection in respect of the Invention in the United Kingdom and throughout the world;
 - 1.4 the right to make any new Application or Applications in respect of any part or parts of the subject matter of any application or specification filed in connection with the Invention in the United Kingdom and the right to claim priority under Section 5 of the Patents Act 1977 from the Application;
 - 1.5 any Patents under the Patents Act 1977 or other similar forms of protection granted in respect of the Invention in the United Kingdom pursuant to the Application;
 - 1.6 the right to bring proceedings (in the United Kingdom under Section 61 or Section 69 of the Patents Act 1977) for any previous infringement of the rights assigned by this Assignment; and
 - 1.7 the right to claim priority of the Application under the Paris Convention (as amended) when making Applications in countries or territories outside the United Kingdom

TO HOLD the same unto the Assignee absolutely.

2. The First Assignor, the Second Assignor, the First Inventor and the Second Inventor HEREBY COVENANT with the Assignee that they will at the expense of the Assignee execute sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned and (if requested to do so by the Assignee) to apply for any Patents or other forms of protection in respect of the Invention throughout the world and fully and effectively to vest the same in the Assignee or as the Assignee shall direct.

3. This Assignment is governed by and shall be interpreted according to the laws of England and Wales.






