lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, his successors, assigns and legal representatives to obtain and enforce proper protection for said invention in all countries.

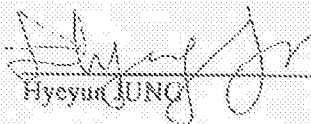
