## RELEASE OF SECURITY INTEREST IN CERTAIN PATENTS

This RELEASE OF SECURITY INTEREST IN CERTAIN PATENTS (this “Release”) is made as of March 27, 2020 (the “Effective Date”) by Bank of America, N.A., as Administrative Agent (the “Administrative Agent”) for the Secured Parties referenced in the Security Agreement defined below, to SPX FLOW, Inc. WHEREAS, in connection with such grant of the Security Interest, a Notice of Grant of Security Interest in Patents (the “Security Interest Notice”) was recorded with the United States Patent and Trademark Office on July 14, 2016 at Reel 039337, Frame 0749;

WHEREAS, the Grantor is disposing of the Released Patents and requests a specific release of the Security Interest granted and recorded against the Released Patents; and

WHEREAS, the Administrative Agent agrees to release the Security Interest granted and recorded against the Released Patents.


NOW THEREFORE, in view of the foregoing:

2. Authorization to Record. The Administrative Agent hereby authorizes and requests that the United States Patent and Trademark Office and any applicable government office record this Release.
3. Applicable Solely to Released Patents. This Release is applicable solely with respect to the Released Patents and does not apply to any other patents or patent applications specified on the Security Interest Notice.
