Assignor hereby requests the Commissioner for Patents, and the corresponding entities or agencies in any other applicable countries, to record Assignee as the assignee and owner of the Patents.

To the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Agreement, the Agreement will govern.

This Assignment and any dispute arising out of or relating to or in connection with this Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws thereof.

This Assignment may be executed in one or more counterparts, and by each of the parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same original instrument. Delivery of an executed counterpart of a signature page to this Assignment by electronic means (including

portable document format) shall be as effective as delivery of a manually executed counterpart of this Assignment.
