

1. The Parent is the indirect 100% shareholder of:  
*Akzo Nobel Chemicals International B.V.*, a company incorporated under the laws of the Netherlands, having its registered office at Velperweg 76, 6824 BM, Arnhem, the Netherlands, registered number: 31038222 (the "Company"),
2. On 1 October 2018, the sale of AkzoNobel Specialty Chemicals to The Carlyle Group and GIC was completed and the new name of the Specialty Chemicals Group is Nouryon.
3. As part of the rebranding of the Specialty Chemicals Group, the name of the Company will be changed into: *Nouryon Chemicals International B.V.* on or around 1 July 2019.
4. Except for the aforementioned name change no other changes (e.g. on packaging other documentation, product composition or – identification like e.g. EAN code's) are envisaged in relation to the Company. The Company will remain in good standing and continue its existing business operations. It will maintain, amongst others, its registered number, its corporate address and its tax registrations as applicable.
