Further, we hereby covenant and agree to and with SmartFume Co., and its successors and assigns, at the time of execution and delivery of these presents, that we are the sole and lawful owners of the entire right, title, and interest in and to the invention and the above-identified patent application(s), and that the same are unencumbered, and that we have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

Further, we agree that we will communicate to SmartFume Co., or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to SmartFume Co., make all rightful oaths, and generally do everything possible to aid SmartFume Co., and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.

We also hereby grant SmartFume Co., its successors, legal representatives, and assigns, the right to insert in this Assignment any further identification (including, but not limited to, patent Application Number) which may be necessary or desirable for recordation of this Assignment.
