**IP SUPPLEMENT**

This IP SUPPLEMENT, dated as of March 31, 2020, is delivered pursuant to and supplements (i) the First Lien Security Agreement dated as of April 29, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and among Sorenson Communications, LLC, a Utah limited liability company, each of the other Loan Parties party thereto, each additional grantor party thereto and Credit Suisse AG, Cayman Islands Branch, as the Collateral Agent, and (ii) the Patent Security Agreement dated as of April 29, 2019 (the “**Agreement**”) executed by the undersigned (“**Grantor**”), among others. 
