AND ASSIGNOR DOES HEREBY authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications or registrations, to issue all patents for the Patents identified in Schedule A to said ASSIGNEE, its successors, its legal representatives and its assigns, in accordance with the terms of this instrument;

AND ASSIGNOR DOES HEREBY sell, assign, transfer, and convey to said ASSIGNEE, its successors, its legal representatives, and its assigns all claims for damages and all remedies arising out of or relating to any violation(s) of any of the rights assigned hereby that have or may have accrued prior to the date of assignment to said ASSIGNEE, or may accrue hereafter, including, but not limited to the right to sue for, seek, obtain, collect, recover, and retain damages and any ongoing or prospective royalties to which ASSIGNOR may be entitled, or that ASSIGNOR may collect for any infringement or from any settlement or agreement related to any of said patents before or after issuance;

AND ASSIGNOR HEREBY covenants and agrees that ASSIGNOR will communicate promptly to said ASSIGNEE, its successors, its legal representatives, and its assigns, any facts known to us respecting the Patents identified in Schedule A, and will testify in any legal proceeding, sign all lawful papers, execute all applications and certificates, make all rightful declarations and/or oaths, and provide all lawful assistance to said ASSIGNEE, its successors, its

legal representatives and its assigns, to obtain and enforce patent protection for the Patents in all countries;

AND ASSIGNOR HEREBY covenants that it will not execute any writing or do any act whatsoever conflicting with these presents.
