TERMINATION AND RELEASE OF PATENT SECURITY INTEREST

This **TERMINATION AND RELEASE OF PATENT SECURITY INTEREST**, dated as of April 2, 2020 ("Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, ("Agent") in favor of POWER SOLUTIONS INTERNATIONAL, INC., a Delaware corporation ("PSI"), BI-PHASE TECHNOLOGIES, LLC, a Minnesota limited liability company ("Bi-Phase") and POWERTRAIN INTEGRATION ACQUISITION, LLC, an Illinois limited liability company ("Powertrain"), and together with Bi-Phase and PSI, each a "Grantor" and together, the "Grantors").

WHEREAS, pursuant to those certain Patent Security Agreements, dated as of June 28, 2013, by and between Agent and PSI (the "PSI Security Agreements"), PSI granted to Agent a security interest in all right, title and interest of PSI in and to certain intellectual property;

WHEREAS, the PSI Security Agreements were recorded at the United States Patent and Trademark Office ("USPTO") at Reel 030743 Frame 0896 on July 1, 2013 and at Reel 038929 Frame 0327 on June 16, 2016;

WHEREAS, pursuant to those certain Patent Security Agreements, dated as of November 2, 2015, by and among Agent, Bi-Phase and Powertrain (the "Bi-Phase/Powertrain Security Agreements", and collectively with the PSI Security Agreements, the "IP Security Agreements"), Bi-Phase and Powertrain granted to Agent a security interest in all right, title and interest of Bi-Phase and Powertrain, respectively, in and to certain intellectual property;

WHEREAS, the Bi-Phase/Powertrain Security Agreements were recorded at the Canadian Intellectual Property Office at Registration 05686456 and the USPTO at Reel 037031 Frame 0490 on November 13, 2015 and at Reel 039019 Frame 0513 on June 27, 2016, respectively; and

WHEREAS, Grantors have satisfied the terms of the IP Security Agreements and request a specific release of the security interest granted and recorded against their respective intellectual property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the IP Security Agreements.

SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby:

(a) terminates the IP Security Agreements and terminates, cancels, discharges, and releases all of its security interests in and to all right, title and interest of Grantors in and to all intellectual property (including, but not limited to, all Patent Collateral), whether granted pursuant to the IP Security Agreements or otherwise (and including, but not limited to, the Patents listed on Schedule A attached hereto); and

(b) reassigns and transfers to Grantors all of their respective right, title and interest in and to all intellectual property, whether granted pursuant to the IP Security Agreements or otherwise (including, but not limited to the Patents listed on Schedule A attached hereto).

(c) authorizes Grantors or any of their authorized representatives to file this Release with the USPTO or any similar office or agency within or outside the United States at Grantors' expense;

(d) further authorizes and requests that the Commissioner for Patents and any other applicable government officer record this Release; and

(e) agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Grantors, at Grantors' expense, to fully effectuate the purposes of this Release.

SECTION 4. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Illinois.
