

ASSIGNOR covenants with said ASSIGNEE, its successors, assigns and legal representatives that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by the undersigned, and that full right to convey the same as herein expressed is possessed by the undersigned; and

ASSIGNOR further covenants and agrees that it will communicate to ASSIGNEE, its successors, assigns or other legal representatives, any facts known to it respecting the PATENT RIGHTS, and testify in any legal proceeding, sign all lawful papers, execute all reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE, its successors, assigns or other legal representatives to obtain and enforce proper patent protection for said PATENT RIGHTS.
