assignments in connection with such application(s) as the Assignee may deem necessary or expedient.

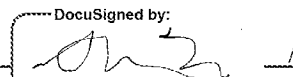

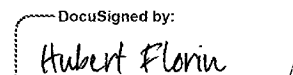

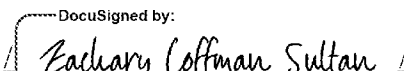
