
NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby sell, assign and transfer to ASSIGNEE, its successors, assigns or other legal representatives, the entire and exclusive right, title and interest to THE PATENT and any and all applications which are continuations, continuations-in-part, divisions or substitutes of THE PATENT and any and all Letters Patent that may be granted therefore, in the United States and throughout the world, for the full term or terms for which said Letters Patent may be granted; authorize and request The Director of Patents and Trademarks of the United States and similar officials in all foreign countries to transfer record title to, and issue all such Letters Patent to, said ASSIGNEE, its successors, assigns or other legal representatives; covenant that no assignment, sale, agreement, transfer or encumbrance has been, or will be, made or entered into which would conflict with this Assignment, sale and transfer; and agree to communicate to ASSIGNEE, its successors, assigns or other legal representatives, upon request and at no cost or expense to ASSIGNOR, any facts known by us respecting said inventions/designs, do all lawful acts, including the execution and delivery of all papers and proper oaths and the giving of testimony that is deemed necessary or desirable by ASSIGNEE, its successors, assigns or other legal representatives with regard to said inventions/designs for protecting, obtaining, maintaining and enforcing any and all of said Letters Patent in the United States and throughout the world for said invention and for perfecting, affirming, recording and maintaining the title of ASSIGNEE, its successors, assigns or other legal representatives, and generally cooperate to the fullest extent in all matters pertaining to said invention, any and all of said Letters Patent, and the title thereto in ASSIGNEE, its successors, assigns or other legal representatives. Should ASSIGNOR be unable or unwilling to do said acts and/or execute and deliver said papers and oaths, ASSIGNOR hereby irrevocably appoints ASSIGNEE as its agent to do said acts and execute said papers and oaths on ASSIGNOR'S behalf and in ASSIGNOR'S name.

ASSIGNOR also transfers to ASSIGNEE the entire and exclusive right to sue for infringements occurring prior to and after this transfer, and to collect and keep all damages for such infringements, without any accounting to ASSIGNOR.

This Assignment may be executed in counterparts, which together constitute the entire Assignment.
