ASSIGNMENT

WHEREAS, we, **DAVID A. ROBERTS, HAO-YU LIN, H. MONTGOMERY MANNING, MICHEL P. 3. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments throughout the world to issue or transfer all said Letters Patents to ASSIGNEE, as assignee of the entire right, title, and interest therein or otherwise as ASSIGNEE may direct;


