NOW THE PARTIES AGREE follows:


1. In consideration of the sum of Hong Kong Dollar One Only (HK\$1.00) to be paid by the Assignee to the Assignor, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby assigns to the Assignee all of the Assignor's rights, title and interest (including without limitation all rights to sue for past, present and future infringement, to collect royalties and all causes of action and enforcement rights, whether known or unknown, currently pending or otherwise, including the right to pursue damages, injunctive relief and other infringement remedies) in respect of the said invention, the said application and any corresponding utility applications and all divisions, renewals and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same priority rights derived from the said United States application under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international Agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without

limitation, patents, utility models, inventors' certificates and designs which may be granted for the said invention in any country or countries foreign to the United States and all extensions, renewals and reissue thereof.

2. The Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this Assignment.
3. The Assignor has the full right to convey its entire interest herein assigned, and that the Assignor have not executed, and will not execute, any agreement in conflict herewith.
4. The Assignor will communicate to the Assignee, its successors, legal representatives and assigns, any facts known to the Assignor respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all utility applications, divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the Assignee, its successor, legal representatives and assigns, to obtain and enforce proper protection for said invention in all countries.


