AND I HEREBY further covenant and agree that I will communicate to RABUGINO SP. ZO.O., its successors, legal representatives and assigns, any facts known to me respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid RABUGINO SP. ZO.O., its

successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in the United States;

AND I HEREBY grant Heslin Rothenberg Farley & Mesiti, P.C. the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document;

AND I HEREBY, as the above-named inventor, declare that the above-identified application was made or authorized to be made by me;

AND I HEREBY, as the above-named inventor, declare that I believe that I am the original inventor of a claimed invention in the above-identified application;

AND I HEREBY state that I have reviewed and understand the contents of the above-identified specification, including the claim;
