In addition, the ASSIGNOR(S) hereby authorize and request any official whose duty it is to issue patents, to issue any patent on said improvements or resulting therefrom to Rogers BVBA, its successors, legal representatives, and assigns, the entire worldwide right, title, and interest in and to the same to be held and enjoyed by Rogers BVBA, its successors, legal representatives, and assigns to the full end of the terms for which any and all such patents may be granted, as fully and entirely as would have been held and enjoyed by the ASSIGNORS had this Assignment not been made; and the ASSIGNOR agrees on behalf of themselves, their successors and legal representatives, to execute any and all documents and instruments and perform all lawful acts reasonably related to recording this Assignment or perfecting title to the INVENTION, the APPLICATION, and any and all related patents and applications, in Rogers BVBA, its successors, legal representatives, and assigns, whenever requested by Rogers BVBA, its successors, legal representatives, and assigns.

The ASSIGNOR(S) also hereby grant Rogers BVBA, its successors, legal representatives, and assigns, the right to insert in this Assignment any further identification of the APPLICATION (including, but not limited to, Application Number and filing date, and Attorney Docket Number), and further grants Rogers BVBA, its successors, legal representatives, and assigns the right to execute confirmatory assignments on their behalf.

The undersigned declare that all statements made herein of their own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so
