1. The name and jurisdiction of incorporation of the corporation making the election is **AMERICAN MEGATRENDS, INC.**, a Georgia corporation (the "Company").

2. The Company elects to become a limited liability company organized under the laws of the State of Delaware pursuant to a plan of conversion (the "Plan of Conversion"), and its name shall be **AMERICAN MEGATRENDS INTERNATIONAL, LLC** (the "Delaware LLC").

3. The effective date and time of the conversion shall be upon filing of this Certificate of Conversion by the Georgia Secretary of State.

4. The Plan of Conversion has been adopted as required by subsection (c) of Section 14-2-1109.3 of the Georgia Business Corporation Code, as amended.

5. The authority of the registered agent of the Company to accept service on behalf of the Company is revoked as of the effective time of the conversion and the Secretary of State is irrevocably appointed as the agent for service of process on the Delaware LLC in any proceeding to enforce an obligation of the Company arising prior to the effective time of such conversion.

6. The Delaware LLC's mailing address to which a copy of any process served on the Secretary of State under Section 5 hereof may be mailed is: 200 Bellevue Parkway, Suite 210, in the City of Wilmington, Zip Code 19809. The name of its registered agent at such address is Intertrust Corporate Services Delaware Ltd.

7. The Secretary of State shall be notified of any change in the Delaware LLC's mailing address.
