## 1. GRANT

**1.1. Exclusive License Grant.** Subject to the terms of this Agreement, Licensor grants to Licensee the worldwide, exclusive right and license under the Patents to make, have made, use, import, offer or sell products or services covered by the Patents, including the exclusive right to grant licenses or sublicenses to sue for and collect past, present and future damages, to settle any such lawsuits on such terms as determined by Licensee (whether related to past, present or future infringement of the Patents), to seek and obtain injunctive or any other relief for infringement of the Patents and to sell the Patents. The grant to Licensee of the exclusive right and license under the Patents herein shall be exclusive even as to Licensor, and Licensee shall have the sole and exclusive right under the Patents to deal with one or more parties in any and all matters relating to the Patents, including without limitation any and all direct and indirect offers for sale and sales of products and services, in whole or in part, covered by the Patents. Licensor expressly retains no rights in or to the Patents, including without limitation the right to sue for infringement of the Patents prior to any termination of this Agreement, and specifically grants to Licensee all such rights prior to any termination of this Agreement. The exclusive right and license granted herein shall exist until this Agreement is terminated as provided in Section 6 below.

**1.2. Defend the Patents.** Except as otherwise provided herein, Licensee agrees that Licensee has a duty to and will defend, in a commercially reasonable manner and at its sole expense, any legal challenges to the validity or enforceability of the Patents, including but not limited to *Ex Parte* Reexamination, *Inter Partes* Reexamination, *Inter Partes* Review, Interferences, Derivation proceedings, and Post Grant Review proceedings.

**1.3. Licensor Retains No Substantial Rights.** During the term of this Agreement, Licensor retains no rights in or to the Patents, including without limitation any rights to sue for and collect past, present, and future damages and to seek and obtain injunctive or any other relief for infringement of the Patents, and has no other rights with respect to enforcement of the Patents except as explicitly set forth in this Agreement.
