## ASSIGNMENT OF PATENT RIGHTS

"Patents" shall not include (a) inventions described in U.S. Patent Application Serial No. 14/405,052 that include the Excluded Subject Matter; (b) applications for patent or patent certificate, reissues, reexaminations, extensions, continuations, continuations in part, continuing prosecution applications, requests for continuing examinations, divisions, and registrations of any item in any in (a) that include the Excluded Subject Matter; (c) national (of any country of origin) and multinational patents, patent applications and counterparts relating to any item in any of the foregoing categories (a) through (b), including, without limitation, certificates of invention and utility models that include the Excluded Subject Matter; and (d) rights provided by multinational treaties or conventions for any item in any of the foregoing categories (a) through (c) that include the Excluded Subject Matter.
