EXPLANATION OF ERROR IN RECORDATION FORM COVER SHEET

Honorable Commissioner:

- 1) The recordal at reel/frame 021272/0763 on July 22, 2008 has an error in the document execution date, due to a typographical error on the applicant's submitted Recordation Form Cover Sheet. The correct document execution date is June 26, 2007 i.e. 06/26/2007 instead of the incorrectly indicated 06/26/2002.
- 2) The incorrect date was a typographical error on the Recordation Form Cover Sheet, or from mis-reading the handwritten date entered by the inventor on the Assignment. It is clear that the date must be 06/26/2007 and not 06/26/2002 because the Assignment had not even been presented to the inventor for signature in

2002. Namely, the affected US Patent Application 11/807,843 was only filed on May 30, 2007, based on and claiming the foreign priority of a German priority application filed on May 30, 2006. The Inventor Declaration and the Assignment were both together signed on June 26, 2007. The handwritten date entered in the Inventor Declaration can be read somewhat more clearly. Also, the Declaration refers to the German priority application filed on May 30, 2006, which would not have been possible for a signature date back in 2002.

- 3) For correction of the document execution date in the recordal, we are enclosing a copy of the originally recorded Assignment document and a corrected cover sheet, as well as a copy of the simultaneously executed Inventor Declaration for additional information.



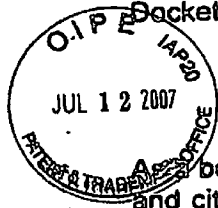
