## ASSIGNMENT

3. ASSIGNOR agrees to sign all necessary papers, give testimony if required, to perfect and defend the rights of ASSIGNEE in said PATENT, as it may reasonably require and cooperate with ASSIGNEE in all other matters relating to the assignment of the PATENT.
