And WE hereby covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute any agreement or other instrument in conflict herewith.

And WE hereby further covenant and agree that we will communicate to the assignee herein, its successors, legal representatives and assigns any facts known to us respecting said Invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing, renewal, reissue and extension applications, make all rightful declarations, and generally do everything possible to aid the assignee herein, its successors, legal representatives and assigns in obtaining and enforcing proper patent protection for said Invention in all countries of the world.
