This PATENT ASSIGNMENT (the "Assignment") is made as of the date of _____, by **Autoliv Development AB**, a corporation having a place of business at Wallentinsvagen 22, 44783 Vargarda, Sweden ("Assignor") and **Veoneer Sweden AB**, having a place of business at Wallentinsvagen 22, 44783 Vargarda, Sweden ("Assignee") (collectively, the "Parties").

WHEREAS, pursuant to a spinoff by Assignor to create Assignee as an independent company, the Parties agree to enter into this Agreement;

WHEREAS, the Assignor owns the patent applications and patents as set forth on Schedule I attached hereto, as well as all patents and patent applications (such as divisional applications, continuation applications, national applications derived from regional applications) generated from any of the applications listed herein (collectively, the "Assigned Patents"); and

WHEREAS, Assignee desires to receive and acquire all of the Assignor's right, title and interest in and to the Assigned Patents;

NOW, THEREFORE, subject to the terms and conditions of the above-mentioned spinoff and in consideration thereof, the receipt of which is hereby acknowledged, the Parties hereto, intending to be legally bound, agree as follows:

1. Effective as of July 1, 2018 ("Effective Date"), the Assignor hereby sells, conveys, assigns and transfers to Assignee, and the Assignee hereby accepts all rights, title and interest in and to the Assigned Patents, including all corresponding applications such as, continuation, continuation-in-part, divisional, provisional, reissue, reexamination thereof and the subject matter of any and all claims which may be obtained in every such patent, as well as all corresponding foreign patents, foreign patent applications, free and clear of all encumbrances; all rights to apply for registration in all countries with full benefit of such priority as may now or hereafter be granted to it by law, treaty, or other international convention; and all rights, interests, claims and demands recoverable in law or equity, that the Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Patents, including, without limitation, the right to compromise, sue for and collect such profits and damages; all of the foregoing to be held and



enjoyed by Assignee, their successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this Assignment had not been made.

2. From and after the Effective Date, the Assignor shall, without further consideration, execute and deliver such instruments or transfer, conveyance, assignment and assumption, in addition to any other ancillary agreements and does enter and take such other action as may be necessary to consummate this Assignment.

3. Nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand, supersede or limit in any way the terms, conditions or obligations between the Parties.

4. This Assignment shall be governed by, and construed in accordance with, the laws of Sweden, in respect to patent issued and in all other respects including as to validity (except for patent validity issues), interpretation an effect by the laws of Sweden without giving effect to the conflict of laws rules thereof.

5. This Assignment may be executed electronically or otherwise (where permitted in an applicable jurisdiction) in any number of identical counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.


