ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT is made this 2nd day of March 2020

BETWEEN

PAUL HUNG CHUN LIANG (Singapore Citizen) of 5 Mount Echo Park, Singapore 248769 (hereinafter known as "**the Assignor**"), of the one part;

AND

PAUL HUNG CHUN LIANG (Singapore Citizen) of 5 Mount Echo Park, Singapore 248769 (hereinafter known as "**1st Assignee**"), of the one part;

JANPAUL PTE. LTD. (UEN 201130794C), a corporation duly organised and existing under the laws of Singapore, with registered address at 545 Orchard Road # 10-02 FAR EAST SHOPPING CENTRE Singapore 238882 (hereinafter referred to as the "**2nd Assignee**") of the other part;

RECITALS

(A) The Assignor is the Applicant and Proprietor of the United States Design Patent/United States Design Application (hereinafter referred to as "United States Design Patents") and Singapore Registered Designs, particulars of which are set out in Schedule A.

(B) In consideration of the payment to the Assignor of Singapore Dollars Ten (10), receipt whereof is hereby acknowledged, Assignor agrees that one-half (1/2) of his share in the United States Design Patents and Singapore Registered Designs and all rights associated with that part of his share of the US Design Patents and Singapore Registered Designs shall be transferred to the 2nd Assignee with effect from the date hereof.

(C) After completion of the assignment, the 1st and 2nd Assignee each would have a half share (1/2) in the United States Design Patents and Singapore Registered Designs and would be entitled to the benefit of one half (1/2) share each in the United States Design Patents and Singapore Registered Designs.

NOW THIS AGREEMENT WITNESSES as follows :

1. In consideration of the sum mutually agreed by both parties (the receipt of which the Assignor hereby acknowledges) , the Assignor hereby assign absolutely a half share of all rights, title and interest in respect of the United States Design Patents and Singapore Registered Designs .
2. The Assignor shall at the direction and expense of the Assignees execute any further document that the Assignees may reasonably require to enable the Assignees to become registered as the joint proprietors of the US Design Patents and Singapore Registered Designs.
3. The Assignor hereby warrants that:
 - 3.1 at the date hereof all fees due in respect of the US Design Patents and Singapore Registered Designs Applications have been duly paid;
 - 3.2 he is not aware of any acts committed by third parties which would amount to infringement of the US Design Patents and Singapore Registered Designs;
 - 3.3 he has not granted any licenses or any other permissions to use any design covered by the US Design Patents and Singapore Registered Designs to any third party;
 - 3.4 the exercise by the Assignees of their rights assigned to each pursuant to this Assignment will not infringe the rights of any third party;
 - 3.5 at the date hereof no actions have been commenced or remain outstanding claiming the invalidity of the US Design Patents/Singapore Registered Designs or any part of them.
4. This Assignment may be validly executed in a number of counterparts which when read together contain all signatures of the parties.
5. In the event of any difference or dispute arising between the Parties relating to the validity, interpretation, construction or performance of this Agreement, the Parties will use their

best endeavors to settle amicably such difference or dispute by consultation and negotiation. If such efforts taken pursuant to this Clause fail, then the Parties will refer the matter to mediation in accordance with the rules and procedures of the Singapore Mediation Centre.

6. The construction, validity and performance of this Agreement will be governed in all respects by the Laws of the Republic of Singapore (excluding conflicts of laws), except that questions affecting the construction and effect of any United States Design Patents or Singapore Registered Design will be determined by the law of the country in which such Design Patent or Registered Design has been granted. The Parties hereby submit to the non-exclusive jurisdiction of the courts of the Republic of Singapore.


