FURTHERMORE, to confirm full ownership by the Employer of the Invention, Patent Application, and Patents which may be granted for the Inventions, even against a contrary determination by any authority, including courts of the United States or any other country for any reason, the Inventor hereby assigns, sells, and transfers to the Employer in exchange for compensation to the Inventor as required under German law that is good, valuable, and legally sufficient, the receipt of which the Inventor hereby acknowledges, the entire right, title, and interest in and to the Invention and the Patent Application, and any and all Patents in the United States of America and all foreign countries that may be granted for the Invention or on the Patent Application, including any and all divisions, continuations, and continuations-in-part of the Patent Application, reissues, reexaminations, renewals, and extensions of said Patents, as well as the full right to claim for any such Patents all benefits and priority rights under any applicable convention, treaty, or legislation, and the right to sue and obtain relief, including damages, profits, and injunctions, for any infringement occurring before or after issuance of the Patents.

The Inventor hereby authorizes and requests each national Patent Office to issue the Patents to the Employer or to the successors, legal representatives, or assigns of the Employer.
