continuations thereof, including the right to file foreign applications directly in the name of ASSIGNEE and to claim priority rights deriving from said United States application to which said foreign applications are entitled by virtue of international convention, treaty or otherwise, said Applications and all patents based on said Applications to be held and enjoyed by ASSIGNEE and its successors and assigns as fully and entirely as the same would have been held and enjoyed by ASSIGNORS had this assignment, transfer and sale not been made. ASSIGNORS hereby authorize and request the Commissioner for Patents and Trademarks to issue all patents based on said Applications to ASSIGNEE. ASSIGNORS agree to execute all instruments and documents required for the making and prosecution of applications for United States and foreign patents based on the Applications, for litigation regarding the patents, or for the purpose of protecting title to the Applications or patents. If not already present, Assignors hereby authorize the Assignee, or Assignee's attorney or agent, to insert the filing date and application number of the Applications when known.
