Assignor further agrees to execute all papers necessary in connection with any litigation or other governmental, statutory or legal proceedings which may commence or be declared concerning the Priority Applications and any intellectual property rights to be obtained therefor on said applications or any subsequent patent applications related thereto, and to cooperate with the Assignee in every way possible in obtaining and producing evidence and proceeding with any such litigation or other governmental, statutory or legal proceeding.


This Assignment may be executed in two or more counterparts, each of which will for all purposes be deemed to be an original but all of which together will constitute one and the same instrument.


This Assignment will inure to the benefit of, and be binding upon, the respective successors and assigns of the Assignor and Assignee.


