## EXTENSION AGREEMENT

THIS AGREEMENT made effective as of this 8<sup>th</sup> day of June, 2017

BETWEEN

ILLUMA-Drive Inc., a corporation incorporated under the laws of Ontario  
(hereinafter referred to as the "Corporation");

- and -

Sean Roosen, an individual domiciled and resident in the Province of Ontario  
(hereinafter referred to as the "Holder").

WHEREAS the Corporation and the Holder entered into the following promissory notes (collectively, the "Notes");

- (i) a term note dated July 21, 2016 whereby the Corporation promised to pay the Holder, the principal sum of Cdn. \$50,000 bearing interest of 10% per annum originally due and payable on December 31, 2016, which due date was extended to June 30, 2017 by an amending agreement dated December 13, 2016; and
- (ii) a term note dated December 21, 2016 whereby the Corporation promised to pay the Holder, the principal sum of Cdn. \$115,000 bearing interest of 10% per annum due and payable on June 30, 2017;

AND WHEREAS pursuant to the Notes as amended the principal amounts and interest are due and payable on June 30, 2017 (the "Maturity Date");

AND WHEREAS the parties hereto wish to extend the Maturity Date and to make certain corresponding amendments to the Notes;

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of the mutual agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties hereto, the parties hereby agree as follows:

1. The Notes is hereby amended by replacing "December 31, 2016" and "June 30, 2017", as the case may be, in the first paragraph of the Notes with "December 31, 2018".
2. All other terms of the Notes shall remain in full force and effect unamended and are hereby ratified by the parties hereto in all respect.
3. This Extension Agreement shall enure to the benefit of and be binding upon the parties and their respective successors and legal personal representatives.

4. This Extension Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.

5. This Extension Agreement may be executed in counterparts, delivery of which may be effected by means of an electronic transmission, and each such counterpart shall constitute an original document and such counterparts, taken together, shall constitute one and the same instrument.
