

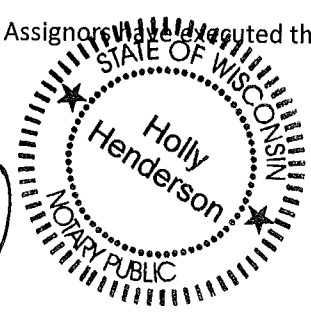
other acts as Assignee may lawfully request in order to obtain, maintain or enforce the Patent Application and any resulting Patent(s) in any and all countries.

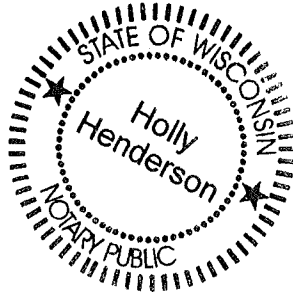
