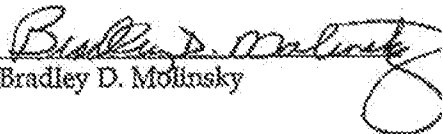
SYSTEM AND METHOD FOR INTEGRATED ADVANCE LIFE PLANNING

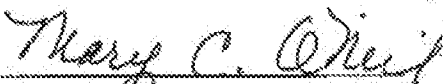
