ASSIGNMENT AGREEMENT

This Assignment Agreement (the "**ASSIGNMENT AGREEMENT**") is made effective as of the 17th day of May, 2018 (the "Effective Date") by and among:

Ira D. McCauley ("ASSIGNOR") an individual of the full age of majority, domiciled in the State of Missouri, with a mailing address of 16 White River Lane, Defiance, Missouri, 63341;

MOmarsh, Inc. ("SELLER") a business corporation, validly existing and duly incorporated under the laws of the State of Missouri, with a mailing address of 16 White River Lane, Defiance, Missouri 63341, represented herein by Ira McCauley, its duly authorized director, sole shareholder, and President;

and

Higdon Outdoors, LLC ("ASSIGNEE"), a limited liability company, validly existing and duly organized under the laws of the Commonwealth of Kentucky, with a mailing address of 2800 Adams Street, Suite B, Paducah, Kentucky 42001, represented herein by John Higdon, its duly authorized Agent.

For good and valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR, SELLER, and ASSIGNEE (sometimes collectively or individually referred to as the PARTIES or a PARTY) hereby agree as follows:

The "**PATENT RIGHTS**" shall mean the patents and patent applications set forth in Exhibit A.

The PARTIES are entering into an "Asset Purchase Agreement" of even date. The present ASSIGNMENT AGREEMENT is intended to memorialize with greater particularity some of the rights and obligations of the PARTIES under the Asset Purchase Agreement. This ASSIGNMENT AGREEMENT and the Asset Purchase Agreement are intended to complement one another; and both shall be given full force and effect. Where an otherwise irreconcilable difference may exist between the two, the present ASSIGNMENT AGREEMENT shall take priority over the Asset Purchase Agreement, but only to the extent necessary to resolve the difference.

ASSIGNOR hereby assigns all ASSIGNOR's right, title, and interest in the PATENT RIGHTS to ASSIGNEE.

SELLER hereby assigns all of SELLER's right, title, and interest in the PATENT RIGHTS to ASSIGNEE.

ASSIGNOR hereby ratifies all past and future assignments of any or all of the PATENT RIGHTS made by ASSIGNOR in favor of SELLER, or made by ASSIGNOR in favor of ASSIGNEE, or made by SELLER in favor of ASSIGNEE.

SELLER hereby ratifies all past and future assignments of any or all of the PATENT RIGHTS made by SELLER in favor of ASSIGNEE, or made by ASSIGNOR in favor of SELLER, or made by ASSIGNOR in favor of ASSIGNEE.

Each PARTY represents and warrants that he/it has granted no interest in the PATENT RIGHTS to any person or entity other than the PARTIES to the present AGREEMENT. Each party represents and warrants that he/it has no obligations (contractual or otherwise) inconsistent with the present ASSIGNMENT AGREEMENT.

SELLER and ASSIGNEE jointly and severally represent and warrant that, as of the Effective Date, all right, title, and interest in the PATENT RIGHTS in all countries shall be held solely by ASSIGNEE.

ASSIGNOR and SELLER further agree, on their own behalf and on behalf of their respective heirs, executors, administrators, successors, assigns, and nominees, to execute and deliver without further consideration any further applications, assignments, and documents, and to perform such acts as they lawfully may, that may be deemed reasonably necessary by ASSIGNEE, its successors, assigns, and nominees (at ASSIGNEE's expense), fully to secure ASSIGNEE's interest as aforesaid and to obtain or maintain Letters Patent in any and all countries.


ASSIGNOR and SELLER jointly and severally represent and warrant that, as of the Effective Date, neither ASSIGNOR nor SELLER holds any interest in any patent applications or patents in any countries, other than the PATENT RIGHTS defined in Exhibit A. To the extent any such additional patent applications or patents do exist as of the Effective Date, such rights are included in the present ASSIGNMENT AGREEMENT, and ASSIGNOR and SELLER shall each, promptly and without further consideration, execute such additional documents as ASSIGNEE may reasonably request to secure ASSIGNEE's interest in such rights.

The Director of the United States Patent and Trademark Office, and all foreign counterparts to the Director, are authorized and requested to record title to the PATENT RIGHTS to ASSIGNEE, as the assignee of the entire interest therein.

The assigned rights include the right to sue for all past and future infringements.
