may be granted for said Improvements in any country or countries foreign to the United States or claiming priority to the Applications, and all extensions, renewals and reissues thereof; and WE hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for said improvements to **Cold Spring Harbor Laboratory**, its successors, legal representatives and assigns, in accordance with the terms of this instrument;


AND WE HEREBY covenant that WE have full right to convey the entire interest herein assigned, and that WE have not executed, and will not execute, any agreement in conflict herewith;

AND WE HEREBY grant Heslin Rothenberg Farley & Mesiti, P.C. the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.



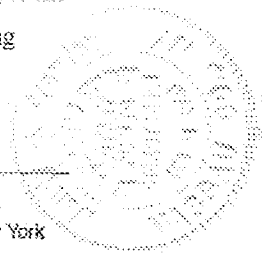
