"AN AUTOMATED AERO AL SCRAPS SORTING SYSTEM BASED LIBS TECHNIQUE"


which is subject to Chinese Patent Application No. 201711139983.7 filed 16 Nov 2017.

NOW, THEREFORE, Assignor hereby acknowledges that pursuant to Project Agreement 2016-405, Assignor has declined participation in perfecting legal rights in Project IP outside of China and that Assignee consequently became the sole owner of all IP rights outside of China; and

Assignor hereby confirms that pursuant to Project Agreement 2016-405 and good and valuable consideration, it has assigned and transferred to Assignee the entire right, title, and interest outside of China in and to the invention and any and all Letters Patent or similar legal protection, foreign or domestic, including any patent applications, continuation applications or divisional applications claiming priority directly or indirectly from the aforesaid Chinese patent application, to be obtained therefor, while the aforesaid Chinese patent application and resulting patents within China, if any, remain jointly owned by Assignor and the CENTRAL IRON & STEEL RESEARCH INSTITUTE pursuant to Project Agreement 2016-405. Assignor acknowledges that all rights and benefits under any applicable treaty or convention, excluding those within China, have been transferred to the Assignee, its successors and assigns, and authorize the Commissioner of Patents and Trademarks of the United States or foreign equivalent thereof to issue the Letters Patent of similar legal protection to the Assignee.

Assignor acknowledges the right of the Assignee, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent or similar legal protection, in its own name if desired, in any and all foreign countries excluding China.



Assignor represent to the Assignee, its successors and assigns, that Assignor has not and shall not execute any writing or do any act whatsoever conflicting with this Assignment. Assignor, its executors or administrators, will at any time upon request, without additional consideration, but at the expense of the Assignee, its successors and assigns, execute such additional writings and do such additional acts as the Assignee, its successors and assigns, may deem desirable to perfect its enjoyment of this grant, and render all assistance in making application for and obtaining, maintaining, and enforcing the Letters Patent or similar legal protection on the invention in any and all countries.
