The foregoing notwithstanding, and in recognition of the fact that Assignee is part of the Bosch group of companies, I hereby assign to Robert Bosch GmbH, a German corporation having a mailing address at Postfach 30 02 20, D-70442 Stuttgart, GERMANY, the limited right to be named as assignee or applicant at the time of publication and at the time of issue on any applications or patents granted as referred to in foregoing paragraphs (2) and (3). If the right applicable to any such patent application allows an assignee to be the applicant of the patent application, Robert Bosch GmbH shall have the right to be identified as applicant of the patent application and the right to claim priority of said United States application. This limited right granted to Robert Bosch GmbH with respect to any patent application or granted patent shall expire upon the first-occurring of (i) assignment to a third party of any of the above-mentioned rights of Assignee, or (ii) with respect to any particular patent, issue of such patent, and shall be subsequently part of the assignable rights of Assignee. All other rights to said invention, said applications and said patents, U.S. or foreign, including the right under


