# Introduction

- A. The Assignor is the owner of the Assigned IP.
- B. The Assignor has agreed to assign, and the Assignee has agreed to accept, the Assigned IP on the terms and conditions of this deed.

# It is agreed

#### 1. DEFINITIONS AND INTERPRETATION

#### 1.1 Definitions

In this deed, unless otherwise indicated by the context:

- (a) providing software products, applications and technical know-how relating to the Services;
- (b) providing devices and other products which utilise the Services to customers; and
- (c) conducting research and development in respect of improvements to the Services, software products and user interfaces relating to the Services, and in respect of new technologies and other products relating to the Services; and
- (d) participating in projects and collaborations with third parties in respect of the Services.

Business Name means the business name "MAXtend" registered in the Australian Securities and Investments Commission business name index.

Circuit Layout means layout designs or plans of integrated circuits used in computergenerated designs used or developed for use in the Business.

Claim means any claim, notice, demand, action, proceeding, litigation, investigation or judgment whether based in contract, tort, statute or otherwise.

Confidential Information means any and all information in oral, visual, written, electronic or other form which relates to or concerns the Business, its goods or services or its clients, including any and all relevant:

- (a) know-how or trade secrets;
- (b) Customer Information:
- (c) emails;
- (d) pitches, tenders and marketing plans;
- (e) personal information for the purposes of the Privacy Act 1988 (Cth); or
- (f) information about the business affairs, activities and practices of the parties or their clients.


Copyright means any works or other subject matter in which copyright subsists that is used or has been developed for use in the Business, including:

- (e) any earlier versions of those works.

Corporations Act means Corporations Act 2001 (Cth).

Customer Information includes but is not limited to customer names, telephone numbers, addresses, details of prior transactions, email addresses, bank account details, credit card details, payment information and any customer lists of the Business.

Data and Files means the files used in the Business which are stored on databases, servers or accessible via software.



**Designs** means the registered designs and applications and all unregistered designs, specifications, technical drawings and plans that are used or developed for use in the Business.

Domain Name means https://www.maxtend.com.au.

Improvements means all improvements, modifications, variations, new versions, or additions to any of the MAXtend IP and any intellectual property rights subsisting in them.

**Inventions** means all new, useful, inventive or innovative devices, substances, methods or processes used or developed for use in the Business other than the Patents.

MAXtend IP means the Business Name, Confidential Information, Copyright, Circuit Layout, Data and Files, Domain Name, Inventions, Patents, Software, Website, Designs, Trade Marks, System, and any intellectual property rights subsisting in them.

Non-Assignable IP means any moral rights or any intellectual property or associated rights of any kind constituting, subsisting in, or arising in connection with the Assigned IP that cannot be assigned.

Patents means the patents and patent applications set out in Schedule 1 of this deed

Software means the software identified in Schedule 2 including an amendable version of the source and operational code required to conduct the Business, user manuals, design documents and specifications in respect of those computer programmes and all versions of them.

Trade Marks means the registered and unregistered trade marks set out in Schedule 3 of this deed.

Website means the website currently located at the Domain Name and any earlier versions of that website.

# 1.2 Interpretation

In this deed, unless otherwise indicated by the context:

- (a) words importing the singular include the piural and vice versa;
- (b) headings are for convenience only and do not affect interpretation of this deed;
- (c) a reference to a clause, paragraph or schedule is a reference to a clause, paragraph or schedule of this deed;
- (d) where any word or phrase is given a definite meaning in this deed, any part of speech or other grammatical form of that word or phrase has a corresponding meaning;
- (e) an expression importing a natural person includes a body corporate, partnership, joint venture, association or other legal entity;
- a reference to a statute, statutory provision or regulation includes all amendments, consolidations or replacements thereof;
- (g) a reference to a party to a document includes that party's legal personal representatives, successors and permitted assigns;



- (h) a covenant or agreement on the part of or for the benefit of two or more persons binds or benefits them jointly and severally; and
- (i) a reference to a body, whether statutory or not:
  - (i) which ceases to exist; or
  - (ii) whose powers or functions are transferred to another body:

is a reference to the body which replaces it or which substantially succeeds to its powers or functions.

#### ASSIGNMENT AND LICENCE

- 2.1 The Assignor hereby wholly and irrevocably assigns to the Assignee all of its current and future rights, title, and interest in and to the Assigned IP (and any improvements) free from any encumbrances or other third party interests, on and from the date of this deed and then, continuously, on the date on which such right, title, or interest is created (if after the date of this deed), including the right to take action and obtain relief (including injunctions, damages and/or an account of profits) arising in respect of any cause of action relating to the Assigned IP (and any Improvements), or the rights in the Assigned IP (and any Improvements), and to enjoy for the Assignee's own benefit the rewards of such action, whether or not that cause of action arises before or after the date of this deed.
- 2.2 The Assignor hereby grants to the Assignee any and all any waiver, consent or licence necessary to use, modify, reproduce, publish, transmit, destroy, sublicense, transfer, or otherwise deal with any Non-Assignable IP (or material in which any rights constituting the Non-Assignable IP subsist) and any other right in, or component of, the Assigned IP (and any improvements) that cannot be assigned in accordance with clause 2.1 on a non-exclusive, perpetual, irrevocable, transferable and fully-sublicensable, world-wide, royalty-free basis (including where a relevant action or omission by the Assignee would otherwise constitute an infringement of a person's rights of attribution or integrity, or against false attribution).
- 2.3 The Assignor irrevocably agrees to promptly execute, or procure that the execution of, all documents, forms and authorisations and do, or procure the performance of, all acts and things that the Assignee considers to be necessary or desirable, or may be required by IP Australia or any equivalent agency or organisation in any other jurisdiction in which the Assigned IP subsists, to give effect to the assignment under this deed and to absolutely vest in the Assignee all rights, title and interests in and to the Assigned IP and Non-Assignable IP as contemplated by this deed and where the Assigned IP (and any Improvements) is able to be registered:
  - apply for registration and facilitate the recording of the Assignee as the registered owner of the Assigned IP (and any Improvements);
  - (b) enable the Assignee to apply for and obtain registration as the registered proprietor of the Assigned IP (and any Improvements) and any or all renewals and extensions thereof, and
  - cancel the record of any registered user's interest or any other party's recorded interest in the Assigned IP (and any Improvements).



## 2.4 The parties agree that:

- (a) in consideration of the supply of the Assigned IP (and any Improvements) and the Non-Assignable IP in accordance with this deed, the Assignee is liable to the Assignor for the amount of \$386,433 (Consideration); and
- (b) the Assignee may offset the obligation to pay the Consideration to the Assignor by any amounts due and payable to the Assignee by the Assignor unless otherwise agreed between the parties in writing.

#### WARRANTIES & INDEMNITY

- 3.1 The Assignor represents and warrants that:
  - the Assignor has (or will produre) all necessary right, authority and capacity to enterinto, execute, and perform its obligations under this deed (including the grant of assignment and licence); and
  - (b) the Assignee's exercise of its rights to Assigned IP and the Non-Assignable IP will not infringe the intellectual property rights or moral rights of any person.
- 3.2 The Assignor continuously releases and indemnifies the Assignee for and against any loss, cost (including legal costs on a full indemnity basis), damage, claim (including for negligence), or expense suffered or incurred by the Assignee and arising in connection with:
  - (a) the Assignor's breach of this deed (including its warranties) or any relevant law, or fraud, negligence, misconduct, or misrepresentation; and
  - (b) a claim that the Assigned IP or Non-Assignable IP, or the Assignee's use of the Assigned IP or Non-Assignable IP, infringes any person's rights (including, but not limited to, intellectual property or moral rights) or defames, injures, harms, or offends any person.

# 4. CONFIDENTIALITY

- 4.1 Both parties agree to keep confidential the terms of this deed and any information or material provided in connection with this deed and marked, or reasonably presumed to be, confidential (Confidential Information). Both parties agree that they will not disclose the Confidential Information unless or until it.
  - is or becomes publicly known through no wrongful act of the receiving party;
  - is received from a third party without restriction and without breach of any confidentiality obligation to the other party;
  - (c) is independently developed by the receiving party; or
  - (d) is required by law to be disclosed (provided that the disclosing party is given advance notice of, and an opportunity to contest, any such requirement if possible and permitted by law).



#### S. GST

- 5.1 If the whole or any part of any amount payable to the Assignor in connection with this Agreement is the consideration for a taxable supply for which the Assignor is liable to pay GST, the Assignor may charge the Assignee, and the Assignee must pay the Assignor, concurrently with the payment of that amount, an additional amount equal to the GST payable in respect of the taxable supply calculated on the basis that the value of the taxable supply is the amount payable for the taxable supply excluding any GST.
- The recovery of consideration for any taxable supply is subject to the Assignor issuing to the Assignee a tax invoice in respect of the supply.
- Any reference to a cost or expenses incurred by the Assignor which is payable by the Assignee excludes any amount of GST forming part of the relevant cost or expense when incurred by the Assignor for which the Assignee can claim a full input tax credit.
- 5.4 A word or term defined in A New Tax System (Goods and Services Tax) Act 1999 (Cth) has the same meaning in this clause 5 where used in connection with the GST imposed under that Act.

This clause does not apply to warranties and representations that this deed expressly sets out.

#### 6.7 Severance

If any part of this deed is invalid or unenforceable, this deed does not include it. The remainder of this deed continues in full force.

# 6.8 No merger


