The Assignor hereby authorizes and requests the issuing authority to issue any and all United States and foreign patents granted on such improvements to and in the name of the Assignee.

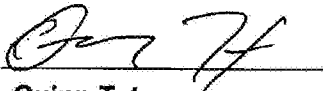
