NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged.



The Assignor hereby assigns, agrees to assign, and confirms the assignment of all legal and/or beneficial rights, title and interest to the Assignee, including the Assignor's entire intellectual property right, title and interest in and to the IP Assets worldwide, inclusive of any continuations, continuations-in-part, divisionals, re-issuances and re-examinations thereof, all rights of priority derived therefrom, any and all patents that may issue on any of the foregoing, and any and all right, title, interest, privileges, damages, settlements and proceeds under, relating to, or arising from the IP Assets, including, without limitation, any claim against third parties for past, present or future infringement or misappropriation of the IP Assets, all of which or the same to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignor had no assignment or transfer been made.

The Assignor hereby agrees, upon request and at the expense of the Assignee, and without further consideration, to communicate to the Assignee or its representatives or nominees any facts known to the Assignor respecting the IP Assets and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing, and reissue

applications, make all rightful oaths and generally aid the Assignee, its successors, assigns, and nominees to obtain, defend and enforce the IP Assets in all countries, and execute any and all further papers which may be necessary or desirable to vest or perfect the title of the Assignee, its successors, transferees and assigns, in and to the IP Assets, or to register title in and to the IP Assets in any intellectual property office worldwide in the name of the Assignee.


