ASSIGNOR further agrees that ASSIGNOR will, without charge to ASSIGNEE, but at ASSIGNEE'S expense, (a) cooperate with ASSIGNEE in the prosecution of any U.S. Patent applications and foreign counterparts on the Inventions and any improvements, (b) execute, verify, acknowledge and deliver all such further papers, including applications and instruments of transfer, and (c) perform such other acts as ASSIGNEE lawfully may request to obtain or maintain any Letters Patents and Registrations which may hereafter be granted on the Inventions and any improvements in any and all countries, and to vest joint title thereto in ASSIGNEE, or their respective successors and assigns.
