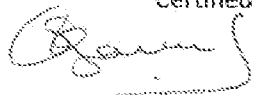

SECOND RESOLUTION

Modification of corporate name and modification of article 2 of the Articles of Association (corporate name)

The General meeting, voting on the quorum and majority conditions for Extraordinary General Meetings, having examined the report of the Board of directors, decides to change the Company corporate name and to adopt as new corporate name : **Orano DS – Démantèlement et Services**.

As a consequence, the article 2 of the Articles of Association will be changed as follows :

« - ARTICLE 2 -- CORPORATE NAME

*The Company corporate name is : **Orano DS – Démantèlement et Services***

All acts and documents issued by the Company and intended for third parties, including letters, invoices, advertisements and various publications, must indicate the corporate name of the Company and its acronym immediately followed or preceded by the words « Société Anonyme » or the abbreviation « S.A » along with the amount of the share capital and Corporate and Trade Registry location and number under which the Company is registered »
