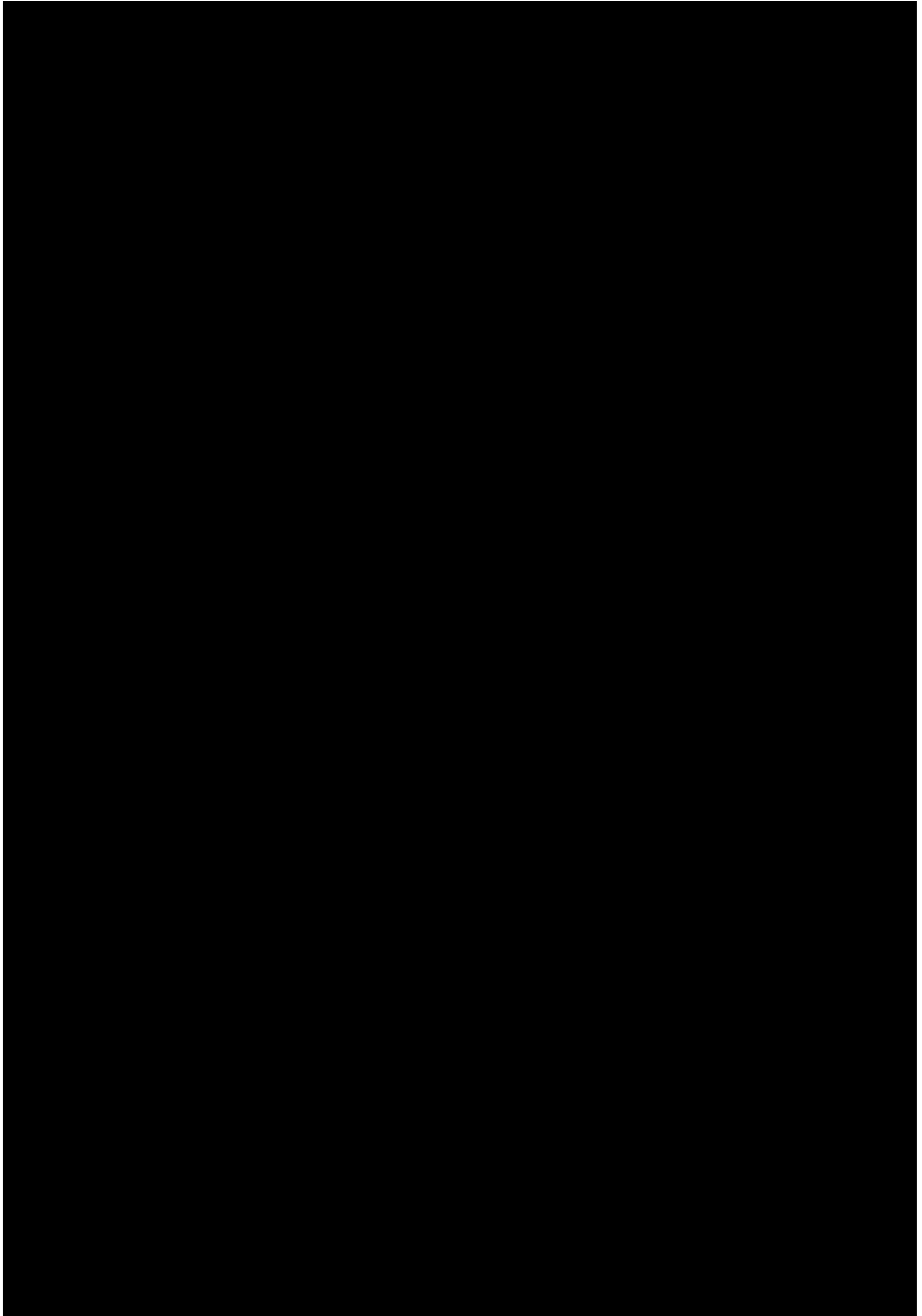


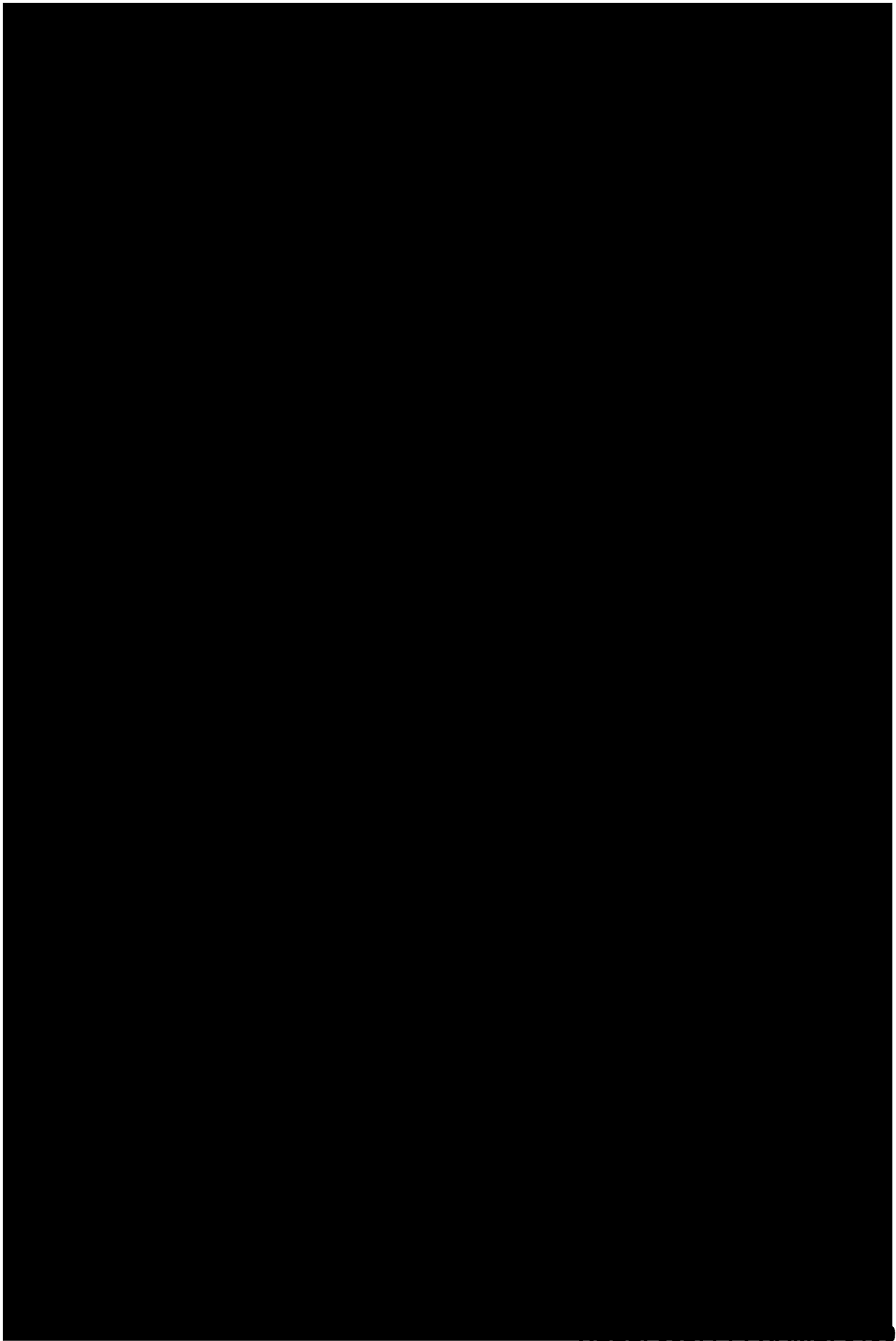


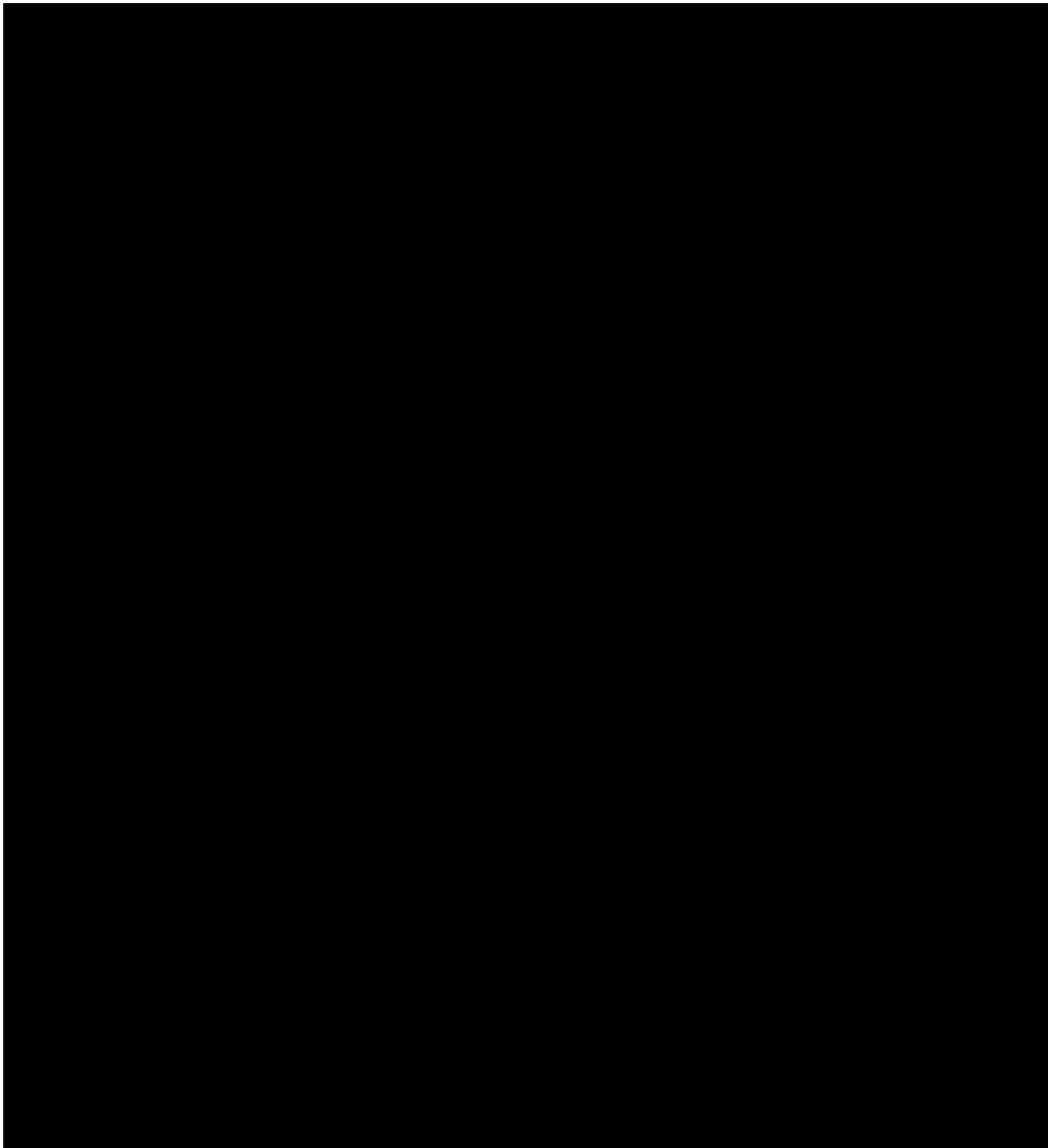
**ARTICLE IV**
