- 3. This Assignment shall become effective as of the Effective Date below when signed by all Parties.
- 4. This Assignment contains the entire understanding of the Parties.
- 5. This Assignment may be amended only by written agreement signed by both Parties.
- 6. If any term, provision, covenant, or condition of this Assignment is held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Assignment shall remain in full force and effect, except as mandated by the court ruling.
- 7. This Assignment, and all claims or actions arising hereunder, shall be construed in accordance with the laws of the State of Utah.
- 8. This Assignment may be executed in counterparts, each of which shall be deemed to be an original and shall be valid and in effect on the date signed. Signatures transmitted by fax or other electronic means shall be deemed to be a valid execution of this document.


