

**RESTATED CERTIFICATE OF INCORPORATION

**(Pursuant to Sections 242 and 245 of the  
General Corporation Law of the State of Delaware)**

**THOUSAND EYES, INC.**, a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "*General Corporation Law*"),

**DOES HEREBY CERTIFY:**

**FIRST:** That the name of this corporation is Thousand Eyes, Inc. and that this corporation was originally incorporated pursuant to the General Corporation Law on August 4, 2009 under the name Thousand Eyes Network Solutions, Inc.

**SECOND:** That the Board of Directors duly adopted resolutions proposing to amend and restate the Certificate of Incorporation of this corporation, declaring said amendment and restatement to be advisable and in the best interests of this corporation and its stockholders, and authorizing the appropriate officers of this corporation to solicit the consent of the stockholders therefor, which resolution setting forth the proposed amendment and restatement is as follows:

**RESOLVED**, that the Certificate of Incorporation of this corporation be amended and restated in its entirety as follows:

**ARTICLE I**

The name of this corporation is ThousandEyes, Inc.

**ARTICLE II**

The address of the registered office of this corporation in the State of Delaware is 3500 S. Dupont Hwy, in the City of Dover, County of Kent, Zip Code 19901. The name of its registered agent at such address is Incorporating Services, Ltd.

**ARTICLE III**

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law.

**ARTICLE IV**
