NOTICE OF RELEASE OF PATENT SECURITY AGREEMENT

- (c) all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement of any Patent or any Patent exclusively licensed under any Patent License, including the right to receive any damages, or right to receive license fees, royalties, and other compensation under any Patent License.

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office on October 14, 2019 at Reel/Frame No.: 050709/0414 and granted a security interest in the Patent Collateral including the Patents listed on <u>Schedule I</u>;
