## PATENTS AND INVENTIONS ASSIGNMENT AGREEMENT

THIS PATENTS AND INVENTIONS ASSIGNMENT AGREEMENT, dated January 1, 2018, is entered into between Visionize LLC, a Delaware limited liability Company (the "Seller"), and IrisVision, Inc., a Delaware corporation (the "Purchaser") with reference to the following facts:

The Seller is the owner of certain inventions and patent applications pertaining to those inventions. The Seller wishes to sell to the Purchaser, and the Purchaser wishes to buy from the Seller, those patent applications and inventions subject to the terms below.

In view of the foregoing facts, the parties agree as follows:

1. Sale of Patent Applications and Inventions. In consideration of the Purchaser's payment to the Seller of one hundred dollars (US\$100.00), receipt of which the Seller acknowledges, the Seller hereby sells, transfers and assigns to the Purchaser: (i) all of the rights of the Seller in the patent applications identified in Exhibit A to this Agreement; (ii) all letters patent that are issued under those patent applications; (iii) all rights in the inventions that are the subject of those patent applications and any continuations, divisions, renewals and substitutes of letters patent so issued with respect to those patents and any reissue or reexamination of the same; and (iv) all letters patent that are issued on any invention described in clause (iii) in addition to those described above (collectively the "Patents and Inventions")
2. Further Assurances. The Seller agrees to execute all documents and take all other actions the Purchaser reasonably requests to effect the transfer of the Patents and Inventions to the Purchaser. These documents and actions include, but are not limited to, the execution of assignments of patents and patent applications to be filed with the United States Patent & Trademark Office and all other government agencies in every country in which applications for patents described in Exhibit A are pending.
3. Power of Attorney. The Seller irrevocably designates and appoints the Purchaser and the Purchaser's authorized officers and agents as the Seller's agent and attorney-in-fact to act for and on its behalf and stead to execute and file any document and to do all other lawfully permitted acts to further the prosecution, issuance and enforcement of all patents issued with respect to the Patents and Inventions with the same force and effect as if executed and delivered by the Seller.
4. Miscellaneous. This Agreement sets forth the entire agreement of the parties concerning the subject matter of this Agreement supersedes all prior or contemporaneous understandings and agreements pertaining to that subject matter. This Agreement may not be amended or terminated except by means of a written instrument signed by both parties to this Agreement.


