ASSIGNMENT

3.1 Assignor represents and warrants that Assignor owns the entire right, title, and interest in the Assigned Patent, that Assignor has not encumbered the Assigned Patent, and that Assignor has granted no third party any license or other interest in the Assigned Patent.

4. MISCELLANEOUS

4.1 Assignor agrees to indemnify and hold harmless Assignee from and against all losses, damages, liabilities and expenses (including, without limitation, reasonable attorneys' fees and charges) resulting from or arising out of any misrepresentation or of any breach of any representation, warranty, or covenant of Assignor in this Assignment.

4.2 Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns, that Assignor will sign all papers and documents, take all lawful

oaths, and do all acts necessary or required to be done for the maintenance, enforcement and defense of the Assigned Patent, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns shall advise, and that any proceeding in connection with the Assigned Patent in any country, is lawful and desirable.

4.3 If any provision of this Assignment shall be held by a court of competent jurisdiction to be contrary to law, the remaining provisions of this Assignment shall remain in full force and effect.

4.4 This Assignment is binding upon, inures to the benefit of, and is enforceable by the parties hereto and their respective successors.
